INTRODUCING THE BOARD ... C. L. JORDAN

Clarence L. Jordan brings a wealth of business acumen and civic experience to his role as Public Relations liaison for Riddle Memorial Hospital.

Presently retired, he was associated with N. W. Ayer and Son, a Philadelphia advertising agency, for 40 years.

He is a member of the Board of Managers of the Franklin Institute and was International Chairman in 1956 for the 250th Anniversary of Benjamin Franklin's Birth. Clarence and his wife, Helen, jointly compiled a book of the history of the Anniversary entitled "Franklin's Unfinished Business", which work was published by the Institute in 1957.

Among his many affiliations are the National United Fund Campaign, the Boy Scouts of America, the English Speaking Union and of course, Riddle Hospital. He engaged actively in the "Citizens for Eisenhower" campaign and is presently participating in the Nixon campaign.

The Jordans have resided in Bowling Green for 38 years. Both avid gardeners, they are looking forward to May 7, when they will serve as hosts for the Bowling Green Auxiliary's Garden Tour. "The Acres" (31 acres of landscaped lawns and woods) will be opened to the public and Helen wishes to stress the fact that all are welcome.

Hodes, Radiology; Robert A. Kimbrough, Jr., Obstetrics and Gynecology. Also, Henry A. Kimmel, representing Media Clinic; Charles T. Mc-Cutcheon, President, Delaware County Medical Society; John J. McGraw, Pathology; Theodore E. Orr, Orthopaedic Surgery; Guy M. Nelson, Internal Medicine and Larry J. Renden, representing the County Medical Center.

Mr. Jordan wishes to clarify the purpose of this Committee. He states: "Some of our members have asked if the Doctors' Advisory Committee which was appointed to work on the architect's plans is to be the Medical Staff of Riddle Memorial Hospital.

The answer is "no". Most of these doctors are already on the staffs of Philadelphia's leading hospitals. They were selected as the most experienced men to bring the Board of Directors counsel on planning the various medical departments in the hospital and they have done remarkably fine work, improving the original plans greatly.

However, most of them are not residents of this area and are not candidates for the Riddle Staff. When final plans are approved and Administrative Management is appointed, the regular Riddle Medical Staff will be selected. Action on this is still some months in the future."
