



### "SIX BOOKS IN SIX MONTHS"

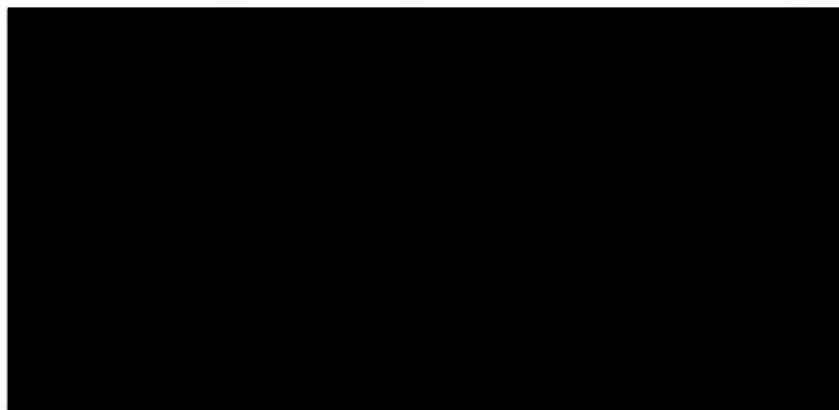
